ORDER GRANTING POST-CONVICTION RELIEF


Before the Court is the Application for Post-Conviction Relief of the Petitioner, which comes on for hearing in open court this 10th day of June, 2015, with the Petitioner present and also represented by counsel, and the State of Oklahoma present. After taking evidence in this matter and hearing the argument of counsel, and upon review of the case file and the pleadings filed by the parties, the Court finds that post-conviction relief should be, and the same is hereby, **GRANTED**.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the Judgment and Sentence in this case is hereby **AMENDED** to reflect a conviction for the crime of MURDER IN THE SECOND DEGREE; further, the sentence is hereby **MODIFIED** to a term of 45 years in the custody of the Department of Corrections, with credit for the time already served by the Petitioner.

It is noted by the Court that the State of Oklahoma objects to the sentence herein, and presented argument for a sentence of life imprisonment in the custody of the Oklahoma Department of Corrections.

This Order constitutes a final order of the Court on the Application and concludes these proceedings. Petitioner had been advised in open court of his right to appeal to the Oklahoma Court of Criminal Appeals, the time frame for doing so, and in open court affirmatively, voluntarily, and knowingly waives his right to appeal this final order and the sentence rendered herein.




