**OKLAHOMA** 

Tressie Rose Shaffer v. State, No. F-2023-395 (Okl.Cr., March 13, 2025) (unpublished): Waiver (Appellate Issues): Shaffer was convicted on Lewd Molestation in Tulsa County. In this opinion the Court affirmed over several claims, but I included it because the Court sprung a procedural trap by waiving a claim of error because appellate counsel had failed "to provide citation to the record on appeal sowing where the evidence was admitted at trial[.]" This is a violation of 3.5(A)(5) of the Court's rules. <u>NOTE</u>: The Court has been aggressive lately in waiving claims where appellate counsel raises two claims under one proposition; and now it appears it is being picky on other parts of the rules governing appellate briefs.

## **TENTH CIRCUIT**

United States v. Joseph Gaye, No. 23-1240 (10<sup>th</sup> Cir., March 11, 2025) (Published) (Tymkovich, Baldock & Eid): Search and Seizure (Search Warrants; Particularity; also Bullet from Leg): Odd case where Gaye was at his office and reported being shot by an intruder. Police realized that he had actually shot himself in the leg, which was a problem because he was a convicted felon. In this opinion, the panel found the search warrant was particular enough and survived on the good faith exception as well. The hospital kept the bullet after it was removed from his leg and gave it to police. The panel found this reasonable as Gaye had requested medical help and removal of the bullet (thus consented) and it was in "plain view" in any event.

<u>United States v. Tegan C. Gulley</u>, No. 24-3078 (10<sup>th</sup> Cir., March 10, 2025) (Published) (Holmes, C.J., Carson & Rossman): **Supervised Release**: Interesting opinion where Gulley was on three-year supervised release, but the Government filed a revocation just before it expired. The district court did not hold a hearing and revoke until six months later, which the majority held was unreasonable, and thus ordered him released. <u>NOTE</u>: Judge Carson dissented, holding that there is no jurisdictional issue.

#### **UNITED STATES SUPREME COURT**

#### **OTHER CASES OF NOTE**

Doerr v. Shinn, No. 09-99026 (9<sup>th</sup> Cir., January 29, 2025): **Habeas Corpus** (**Abeyance**): Capital case where the panel approved the stay-and-abeyance procedure to allow the Petitioner to exhaust state court claims.

United States v. Isac Schwarzbaum, No. 22-14058 (11<sup>th</sup> Cir., January 23, 2025): **Taxes**: This case deals with a wealthy naturalized citizen from Germany holding wealth in bank accounts in Switzerland and Costa Rica. The IRS is nosy and requires a FBAR form to report any foreign bank account information. He failed to do this properly and was assessed penalties. One issue in the case is whether these penalties are punitive and thus restricted by the Eighth Amendment. The First Circuit has held they are not, but in this opinion the Eleventh Circuit disagreed, thus creating a circuit split.

## **SCOTUSblog Publisher Arrested**

An ace appellate lawyer who has argued many cases before the Supreme Court and publisher of the excellent SCOTUSblog website, has been <u>arrested and charged</u> with tax-related federal charges related to high stakes poker. Tom Goldstein has essentially been as close to an appellate rock star as anyone can get. His arrested not only shocked the legal world, but the details are amazing—tales of super high stakes poker sessions where he won and lost millions of dollars.

He had argued more than 40 cases before the Supreme Court before retiring from the legal practice in 2023. The case has had twists and turns, including his release on bond, but subsequent re-arrest as a flight risk when prosecutors alleged he had been moving crypto-currency to bank accounts.

Sometimes truth is stranger than fiction.

## **VICTORIES**

**BOBBY DON GIFFORD**, OKC, secured an acquittal in federal court for a client a few weeks ago which was featured here. However, advocacy does not necessarily end after the trial. A reporter at the Southwest Ledger had printed a blistering article about the client prior to trial. The client was a government employee and the allegations of fraud were harsh. After the acquittal, Gifford reached out to the same reporter who did an updated piece on the case which

included the acquittal. Also, at the end of the article is an interesting stat on acquittals in federal court. According to Southwest Ledger, only 290 of 71,954 defendants in federal criminal cases went to trial and were acquitted in 2022.

**<u>RICK YOHN</u>**, secured a verdict of Not Guilty in a Lewd Acts case out of Dewey County. The mother of the minor stated that she had known of the abuse for years but did not say anything until the client decided to move on with a new woman. Also, during the forensic interview the mother and police officer were allowed to stay in the room and encourage the minor. Great job, Rick!
