Jamie W. Gray v. State of Oklahoma, ex rel. Service Oklahoma, No. 121,655 (Okla. Civ. App., Div. IV, March 28, 2024) (Not for Official Publication): **DUI** (**DPS**): Oklahoma County judge Hon. April Collins sustained a DL revocation, but in this opinion the panel reversed because Service Oklahoma failed to present evidence of an admissible chemical test showing the licensee operated a motor vehicle with a blood/breath concentration of .08 or greater.

## **VICTORIES**

**TOMMY ADLER**, OKC, secured a terrific result in a fatality accident case (no DUI or toxicology, just an allegation of Illegal Passing/Reckless Driving as predicates) in which the State increasingly charges as Manslaughter I instead of a reasonable lesser charge. In this case out of Craig County, Tommy beat the rec on Man I where the client, a 53-year-old with 20+ years as a CDL truck driver, was convicted of misdemeanor Negligent Homicide which fit the facts. Prosecutor Kali Strain suggested 19 years at 85% to the jury in closing, which was one year for every year of the life of the decedent. Instead, the jury convicted on the misdemeanor that it should have been in the first place. Great result, Tommy!

**JOHN MARTINO & MARK BRIGHT**, OKC, got a nice appellate win against DPS in the *Gray* case featured above. Great work, John & Mark!

**DAN POND**, Norman, secured a not guilty verdict in Beckham County in a "weird" case that began when the client sent an e-mail to the Superintendent of his son's school when the son was suspended for striking another student. This somehow turned into a "Terroristic Threat" case, and at PH turned into a Threatening Act of Violence case. Dan attacked the woeful investigation by the Sheriff's Office and reported that the client took the stand and got into a shouting match with the prosecutor, which made the jury uncomfortable, but they set that aside and rendered the just verdict of not guilty. Nice job, Dan!

CHRISTINA HUNT, F.P.D. in Tulsa, secured a victory in the N.D. in the case of a man accused of stabbing another man through the head with a flagpole. The jury went out around 3:30 p.m. and deliberated until 5:30 p.m., then returned in the morning to deliberate until 2:00 p.m. before returning a verdict of not guilty, as well as not guilty on the lesser offense of simple assault. Terrific job, Christina!

**EXECUTION**: Inmate Michael DeWayne Smith is scheduled for execution this week. Defense counsel Mark Henricksen is quoted. Also, district judge Michael Hogan in Pittsburg County has ruled that <u>James Ryder</u> is not competent to be executed.
