### **OKLAHOMA**

No notable cases.

This week was particularly horrible, with nine opinions resulting in nine unpublished affirmances. The resistance of the OCCA to reverse cases continues to get even worse, if that's possible.

### TENTH CIRCUIT

<u>United States v. Germaine Coulter, Sr.</u>, No. 24-6026 (10<sup>th</sup> Cir., April 15, 2025) (Published) (Tymkovich, Carson & Federico) (W.D. Okla.): **Restitution**: Restitution order is affirmed in child sex trafficking case where the district court did not err in determining that Coulter was the but for cause for the injuries suffered by the victims.

United States v. Brandon Keith Thompson, No. 24-4006 (10<sup>th</sup> Cir., April 15, 2025) (Published) (Hartz, Kelly & Rossman): **Possession (Firearm by Felon);** Sufficiency; Commerce Clause; Jury Instructions (Theory of Defense): Conviction for felon-in-possession of firearm is affirmed over claims relating to: 1) faulty jury instructions on actual possession; 2) denial of instruction on his theory of defense; 3) sufficiency of the evidence of actual possession; and 4) unconstitutional exercise of power under the Commerce Clause.

<u>United States v. Jorge Enrique Barragan-Gutierrez</u>, No. 23-8032 (10<sup>th</sup> Cir., April 15, 2025) (Published) (Tymkovich, Ebel & Rossman): **Second Amendment**: Conviction for possession of firearm in furtherance of drug trafficking is affirmed over a challenge based on Second Amendment grounds. <u>NOTE</u>: Barragan-Gutierrez is not a citizen, and the panel noted that there is a circuit-split on the question whether noncitizens maintain a right to bear arms under the Second Amendment and the Tenth Circuit has not answered it.

## UNITED STATES SUPREME COURT

## OTHER CASES OF NOTE

<u>United States v. William Dexter Lucas</u>, No. 23-20602 (5<sup>th</sup> Cir., April 18, 2025): **Restitution; Waiver (Appeals Waiver)**: Lucas obtained small business loans

fraudulently and entered pleas. The district court ordered restitution to both private institutions and the Social Security Administration. The panel held that his attack on the restitution order was not barred by an appeals waiver because he attacked the order as exceeding the statutory maximum; and that he prevailed on the merits regarding the restitution to the SSA.
