#### **OKLAHOMA**

Jeremy Vann v. State, No. F-2022-486 (Okl.Cr., August 3, 2023) (unpublished): **Evidence (Gang Affiliation; Res Gestae)**: Vann was convicted of drug crimes in Muskogee County (the Hon. Timothy King, presiding). The Court affirmed over several claims, including introduction of evidence of gang affiliation (the Court found it admissible as res gestae). NOTE: Judge Rowland, P.J., concurred in result, finding error in the gang affiliation evidence (but harmless). Lewis, J., special concurred, also finding error in the admission of gang affiliation (but harmless).

Robert Leon Hashagen, III, v. State, No. F-2021-203 (Okl.Cr., July 13, 2023) (unpublished): **Judicial Bias**: Hashagen was convicted by jury in Oklahoma

County of Murder in the First Degree (the not-so-honorable and former District Judge Timothy R. Henderson, presiding). The Court reversed on the basis of judicial bias where Judge Henderson had an undisclosed sexual relationship with the prosecutor. NOTE: Judge Lewis dissented on the basis that the relationship ended more than two years before the trial, which to him did not create a probability of actual bias. Judge Lumpkin dissented, finding that there was no prejudice.

<u>CLEET UPDATE</u>: CLEET General Counsel Preston Draper has prepared a very informative and handy 2023 Legal Update featuring cases and new laws.

### TENTH CIRCUIT

<u>United States v. Matthew C. Spaeth</u>, No. 21-3096 (10<sup>th</sup> Cir., June 12, 2023) (Published) (Tymkovich, Phillips & McHugh): **Guilty Pleas; Prosecutorial Misconduct**: In this guilty plea case, Spaeth filed a 2255 to withdraw his plea based on the U.S. Attorney's Office in Kansas listening in on attorney-client phone calls. The panel held that he was not entitled to relief in this tortured opinion. But, you will be reassured that the panel "condemned" the U.S. Attorney's Office.

<u>United States v. Zechariah Freeman</u>, No. 22-2039 (10<sup>th</sup> Cir., June 9, 2023) (Published) (Moritz, Briscoe & Rossman): **Sufficiency; Jury Instructions** (**Sexual Assault**); **Peremptory Challenges**: Conviction for sexual abuse (complaining witness was drunk and asleep) is affirmed over claims relating to: 1) sufficiency of the evidence; 2) refusal to instruct the jury on an essential element of the offense; and 3) denial of a request to use peremptory strikes on alternates.

<u>NOTE</u>: The Tenth Circuit does not have pattern jury instructions for sexual assault, so the parties lifted the ones from the Fifth Circuit, which the panel basically found acceptable.

# OTHER CASES OF NOTE

<u>United States v. Leron Liggins</u>, No. 22-1236 (6<sup>th</sup> Cir., August 3, 2023): **Judicial Bias**: At a pre-trial hearing in a drug conspiracy case, the district judge stated that Liggins "looked like a criminal to me" and that Liggins was doing "what criminals do." This prompted a recusal motion, which was denied, but in this opinion the panel vacated that order, vacated the judgment of conviction and sentence, and remanded to another judge.

# DISCIPLINARY HEARING RE: ISAAC SHIELDS & GEORGE GIBBS, JR.

Prosecutors Isaac Shields and George Gibbs, Jr., have been subject to a disciplinary proceeding in <u>SCBD-7480</u>. The subject of the inquiry is the allegation that both of them spied on a deliberating jury using the courthouse video security feed.

The genesis of the matter stems from a criminal case out of Rogers County in **State v. Kraft**, **CF-2018-465**. Some of the pleadings in that matter pertaining to the motion for a new trial filed by the Defendant are instructive as well.

Since the principal witnesses in the matter are in the Tulsa/Claremore area, the tribunal has opted to hold the **public hearing at the Holiday Inn Express in Claremore on August 17**<sup>th</sup> and 18<sup>th</sup>, 2023. This should be an interesting proceeding, both factually and as to what, if anything, the panel recommends to the Supreme Court. If any of you have cases where this might be an issue, you may want to attend or have a note-taker attend.

### **VICTORIES**

**BRECKEN WAGNER**, McAlester, won a jury trial for a client charged with Child Sexual Abuse in Pittsburg County. He issued a call for a second-chair, which was answered by **MICHAEL TAUBMAN**, who formulated a winning argument on one of the counts. The jury was out just over two hours before returning with the two-word verdict in a touch case. Great work, Brecken & Michael!

## **HEARSAY**

**SHOOTING**: An Edmond police lieutenant shot and killed her brother.

**PROGRAM**: A community-based gun violence program has been launched in NE OKC.

**APPOINTED**: Associate District Judge Rafe Hall has been appointed District Judge by Gov. Stitt.

**APPOINTED II**: Gov. Stitt has appointed Melissa Handke to succeed Craig Ladd as District Attorney in Carter County; also, Carter County has a **new Assistant D.A.** 

**<u>DENIAL</u>**: Cherokee Nation Attorney General Sarah Hill discussed the denial of certiorari in the *Hooper* case.

**MOVE**: Griffin Memorial Hospital is moving from Norman to OKC.

<u>CAMS</u>: NonDoc covers a story about OHP body cams and how to obtain them.

**BOARD**: The City of OKC has voted to establish a permanent Public Safety Advisory Board to review complaints made against police officers.

**ARRESTED**: A woman has been arrested for assaulting a Court of Civil Appeals judge in Tulsa.

**FORFEITURE**: The FAIR act from Congress which reforms civil asset forfeiture, which has rankled law enforcement agencies.

**UNCLEAR**: The Oklahoma County District Attorney has cleared six officers of the OKCPD, but it remains unclear what action the Department will take.

**ARRESTED**: A Canadian County Deputy has been arrested after an accusation of sexually assaulting a woman he was transporting to jail.

**<u>CERT</u>**: The Oklahoma Attorney General has filed a brief in support of Richard Glossip's petition for cert to the Supreme Court.
