### TENTH CIRCUIT

<u>United States v. Raul Guzman</u>, No. 24-2122 (10<sup>th</sup> Cir., August 8, 2025) (Published) (Matheson, Bacharach & McHugh): **Search and Seizure (Standing)**: This case involves denial of a motion to suppress evidence found in a camper trailer where Guzman was living. The panel affirmed on the basis that he lacked a reasonable expectation of privacy and thus lacked Fourth Amendment standing.

<u>United States v. Raymundo Guevara-Lopez</u>, No. 24-2045 (10<sup>th</sup> Cir., August 4, 2025) (Published) (Hartz, Phillips & Federico): **Federal Sentencing Guidelines** (**Disparity**): The defendant pled guilty to bulk-cash smuggling for drug cartels based in Mexico. The range was 24-30 months, but the district court varied upward to the 60-month maximum. He appealed this sentence as substantively unreasonable and in this split opinion, the majority agreed. <u>NOTE</u>: Judge Hartz dissented.

United States v. Dakota Wayne Campus, No. 24-5068 (10<sup>th</sup> Cir., August 4, 2025) (Published) (McHugh, Eid & Federico) (N.D. Okla.): **Federal Sentencing Guidelines (Double Counting; Restraint of Victim)**: Campus assaulted his pregnant fiancée in Indian Country for which he was sentenced to 240-months. In this opinion the panel affirmed over his claim that an adjustment for "restraint" of a victim should not have been applied to him because he had received a different enhancement for conduct that inherently involves a degree of restraint. NOTE: Judge Eid concurred in the judgment only.

## UNITED STATES SUPREME COURT

### **VICTORIES**

JAMES BENITEZ, Kay County, secured a not guilty verdict in a murder case out of Kay County. The State's case revolved a single-person, overly suggestive line-up and told the witness that if she did not cooperate the killer would likely return to kill her and her kids. She admitted at trial that this scared her and that she did not really know who the shooter was. The State tried other tricks, and Judge Lee Turner was not exactly helpful, but this is apparently the sixth acquittal for

James in the last year—with two of them coming in Murder I cases. Great job, James!

**DAN GOOD**, OKC, has teed up an impressive 6-0 record during a two-day span against Service Oklahoma in driver's license hearings in Oklahoma County (some no-shows, some contested hearings). Very impressive, Dan!
