#### **OKLAHOMA**

<u>Derrale Magee v. State</u>, No. M-2023-768 (Okl.Cr., October 10, 2024) (unpublished): **Speeding**: Conviction for speeding at a bench trial out of Texas County (the Hon. A. Clark Jett, presiding) is affirmed over claims related to 1) no proof that the speeding occurred on a highway; and 2) insufficient evidence of speeding. <u>NOTE</u>: This is another appeal on a speeding ticket to come out of Texas County. They do not like speeding tickets.

State v. Krigel, 2024 OK CR 27 (October 3, 2024): State Appeals; Motion to Quash; Attempts: In a prosecution out of Tulsa County for Attempted Rape, the PH magistrate bound the accused over for trial, but since the judges in Tulsa County all recused, the Chief Justice of the Supreme Court appointed the Hon.

Mark Campbell (Bryan County), who granted a motion to quash based upon the PH evidence. The State appealed, and in this opinion the Court reversed, clarifying prior case law and concluding that the PH evidence was sufficient.

### UNITED STATES SUPREME COURT

### **OTHER CASES OF NOTE**

<u>United States v. Sylvester Gailes</u>, No. 23-5928 (6<sup>th</sup> Cir., October 10, 2024): **Second Amendment**: In light of *Bruen*, the Sixth Circuit reconsidered precedent holding that the prohibition on firearms for misdemeanants convicted of domestic violence was constitutional, and held that 18 USC 922 is facially constitutional.

#### **VICTORIES**

**DUSTIN PHILLIPS**, OKC, won a not guilty verdict in Canadian County in a sex offense case. Apparently, Dustin has trials stacked up throughout October, and starting out 1-0 is strong. Great work, Dustin!

**ROB HOPKINS**, OKC, also heard the two magic words in a jury trial out of Oklahoma County. Details are scant but trial wins are awesome. Good job, Rob!

**DAN POND**, OKC, demurred at PH in a meth trafficking case out of Garvin County...sustained! State announced intent to appeal, but this is a great start. Awesome job, Dan!

<u>OSA</u>: The first hearing on an Oklahoma Survivor's Act petition will be held in Seminole County.

**TECH**: The Tulsa County Sheriff is adding the latest technology to its patrol cars.

**ASSAULT**: An OKC man assaulted five officers during a roof-top scuffle.

**HONORED**: The late Judge Ray Dean Linder was honored when a portion of a highway in Woods County was dedicated to him. He was one of the finest jurists our state has ever produced.

<u>AIR</u>: The McClain County Courthouse has "air quality issues" which caused the location of court proceedings to be held at the Community Center.

**BUSTED**: A nation-wide porch-pirate ring has been busted in OKC.

**NEW CHIEF**: The City of Madill has named a new Chief of Police.

**PARTY**: Thirteen people were shot, one fatally, at a Halloween party in OKC.

**HEALTH CARE**: The Oklahoma County Jail has transitioned to self-providing health care to inmates.

**CONFESSION**: A detention officer at the Oklahoma County Jail was arrested for embezzlement, but has also confessed to other offenses.

**NEW**: The City of Pawhuska has a new City Attorney.
